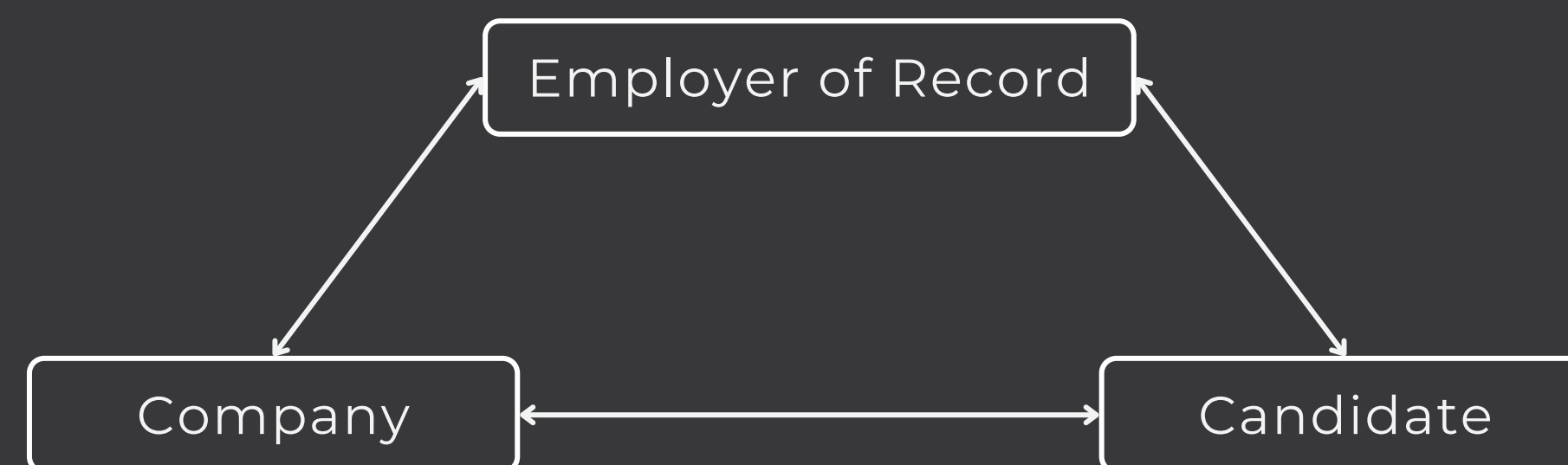


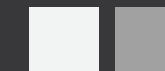


# EOR OVERVIEW

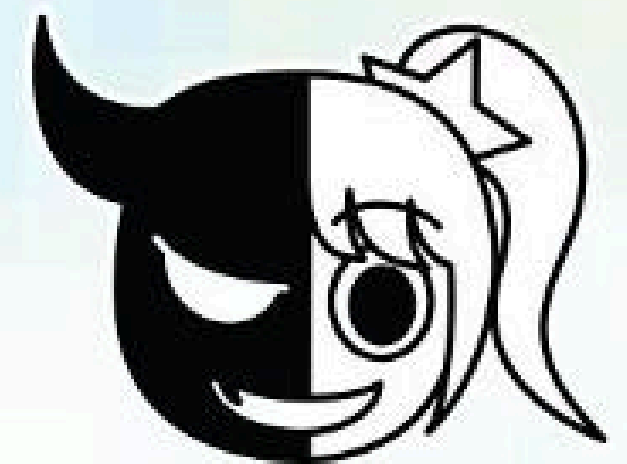

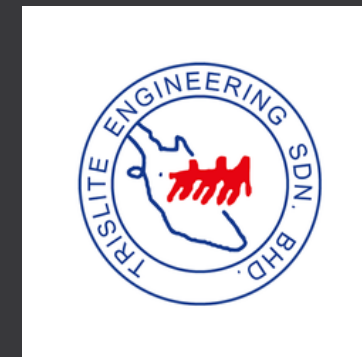
